1. What kind of information is being collected?

Depending on the purpose your data is being collected for, at each moment, the following is collected:

- Personal data, such as name, surname, native language, location, contact data (e-mail, phone number, address), among other info;
- Economic and transactional info (info about your purchases, orders and returns. Etc.);
- Connection, geolocation and browsing info (for mobile interaction, for instance);
- Commercial info (if you are subscribed to our newsletter, for instance);
- Your likes and preferences.

2. The purpose of data collection.

Your personal data will be used for the following purposes:

- To answer the queries communicated via customer service: only the strictly necessary data will be used in order to solve the addressed problem or query;
- For marketing purposes;

- For newsletter subscriptions: we will use your personal data to manage your subscription, which will allow us to personalize info about our products, through different channels (email, for instance). You can cancel your subscription to our newsletter at any moment, without any cost, via our e-mail info@amfurniture.pt;
- For promotional purposes, such as advertising contests or competitions: participating in a
 promotional activity implies the acceptance of the use of your personal data, according to
 each and every activity and its communication through distinct channels, such as social
 media and our website. For every activity, we will provide a proper document stating the
 terms and conditions that apply to it;
- For functional data analysis to improve the quality of our services: if you visit our website, we will use your browsing data for statistical and analytical purposes. This will help us understand the way users interact with our webpage, making us work on its continuous optimization.

3. With whom are we going to share you data?

We will not, in any circumstance, sell or rent your personal information to third parties, regardless of their aim or purpose. The treatment of your personal data will occur according to the European legislation in force.

We may, sometimes, if services are outsourced (services related to our website or marketing activities) allow third parties to access your personal info, guaranteeing they will meet the demands of the same data protection policy standards, being forbidden to use the referred data for their own purposes. The whole process and people involved in it are subjected to professional confidentiality, according to the applicable law.

Furthermore, we would like to add that our website contains links to other online platforms in which our Privacy Policy is no longer effective. We do not take any responsibility and we are not liable for the Privacy Policy of other websites. Therefore, we advise you to read the Privacy Policy of other platforms before submitting your personal data.

For your safety, we will use diverse procedures to help your protect your personal info against unauthorized access, use or dissemination. We will also do everything in our power to avoid the loss, misuse or alteration of the info. We do not offer any kind of warranty and we are not liable for any safety violation or unintentional loss or info dissemination due to the exposure of our website to the internet.

4. What are the customers' legal rights?

Regardless the purpose or legal basis that allows us to use your personal data, you have the right to:

- Have access to the info that we keep about you;
- Ask us to change and correct your personal info;
- Ask us to delete your data, when keeping it no longer fits the initial purpose or when we are no longer legally authorized to do so;

- Ask us to cancel or limit the use of your personal data, meaning that you can ask for a temporary cancelation of your subscription and data use;

Just like you have given us access and consent to use your personal data, you can take it away at any given moment.

5. How long do we keep your personal data for?

We will keep your personal info until you unsubscribe to our newsletter or send us an e-mail to info@amfurniture.pt, stating that you would like us to delete all your data.

Bear in mind that your data will be used for the time strict necessary to guarantee its purpose is fulfilled. Your info will be kept and properly protected afterwards, for the period designated by the law in force, assuring AMfurniture is liable for treating and keeping your data until that period is over.

6. Info about our cookies policy.

We use cookies – small files with info about the user's navigation on our website – and similar processes to facilitate your browsing experience, to understand how you interact with us and, sometimes, to show you adverts, based on your habits and browsing history.

7. Changes regarding data and cookies policies.
